My Job Is To Keep The Peace And To Protect Constituents From All Intrusion

The sheriff's enforcement of an illegal process or Act, federal or local, is illegal!

The sheriff's Constitutional obligation to protect is not limited to the typically perceived function of law enforcement, including the task of arresting a thief or bank robber. The sheriff is a peace officer whose responsibility is to keep the peace and to oppose all forms of Unconstitutional intrusions.

Much like the Nuremberg defendants should not have carried out the regime's orders, County sheriffs should not now carry out poorly conceived judicial orders. Too many judges connect their on-the-bench activities with a politically motivated agenda and issue Unconstitutional orders. County sheriffs have a duty to oppose this oppressive conduct.

As sheriff, and as part of my duty by the oath I take to protect the Constitution, I will not enforce unlawful, Unconstitutional orders, thus forcing an appeals process to a higher authority that will examine a dysfunctional and corrupted judiciary [fn-1].

As to the federal discrepancies, I urge sheriffs to follow the ranks of the sheriffs in Wyoming who have required that all federal agents check in with the sheriff [fn-2].

Although, the Tenth Amendment requires that "[t]he powers not delegated to the [federal government] by the Constitution . . . are reserved to the States" and that "[t]he powers . . . not prohibited by it to the States,

are reserved to the States, federal government chooses, in many instances, to ignore this Constitutional mandate.

As sheriff, I will challenge those who dare to change the law of the land through legitimate-sounding but corrupted legislation on the basis of an interest that is motivated by corporate lobbying and corporate-government meddling for self-interest.

County sheriffs can improve the economy. I intent to bring business to Lee County by improving the housing economy through a law that is already on the books. While most sheriffs fail to understand their Constitutional duties and arrest, rather, people for trespassing, I see no ambiguity in the law. I will, as sheriff, respect the statutorily available adverse possession protections. In light of the banks' unlawful actions, I will whole-heartedly exercise this viable option as long as the Florida Statute and relevant case law are applied by the book.

Lee County needs a strong, experienced sheriff, and not one who is on a learning curve about procedural laws and Constitutional issues as they pertain to the keeping of the peace.

Arresting criminals is only one part of a peace officer's duty. May God forgive for placing the people's safety into the hands of sheriffs who are willing to have the people's Constitutional rights fall into the hands of federal agents.

During the hurricane Katrina relief efforts in Louisiana, federal agents deprived our people of their Second Amendment rights. They confiscated the firearms the people had intended to keep for their personal safety and do so without the permission or oversight of the County sheriff.

Federal government has begun to instill fear into our people, provoking them to give up their rights in the name of a so-called protection from terrorism. As sheriff, I will stand tall against federal [fn-3] encroachments which are intended to strip the people of their rights and personal liberties. As sheriff, it is my duty to protect constituents from federal agents who, under the Unconstitutional Patriot Act, have busted into the living rooms of our people, terrorizing parents, their innocent children, and the elderly because the feds could not conceive the correct addresses, also killing innocent Americans in the process [fn-4].

The sheriff is a Constitutional peace officer and has a duty to keep the peace, by oath. If you want somebody to look over your shoulder, you can vote for me, on November 6, 2012. If, on the other hand, you are comfortable with our economy being run into the ground by federal thugs who conspire against hard-working Americans for self-profits, then stick with a sheriff who increases drug-bust activities just prior to the weeks of
